Notes:

- i. A Class A or Class B Full Member entitled to attend and vote at the extraordinary general meeting shall be entitled to appoint another Class A or Class B Full Member respectively as his proxy to attend and vote subject to the same voting rights as set out in Clause 7(10)(A) of the Insolvency Practitioners Association of Malaysia's (iPAM) Constitution.
- ii. If a Full Member has appointed a proxy to attend this meeting and subsequently he/she attends the meeting in person, the appointment of such proxy shall be null and void, and his/her proxy shall not be entitled to vote on behalf of the Full Member at this meeting.
- iii. The voting procedures for the virtual meeting are as follows:
 - a. Members whom will be appointing a proxy shall place their vote in the Instrument of Appointing a Proxy and submit the proxy form to The Secretariat. The votes will only be taken into account if the proxy attends the meeting.
 - b. Members whom will be attending the meeting shall vote via a link provided on the day of the meeting.

- v. For the purpose of determining members who shall be entitled to attend the meeting, only Class A and Class B Full Members whose names appear on the records of iPAM shall be entitled to attend the said meeting or appoint proxies to attend and vote on their behalf.
